Bid is open to all eligible Nepalese Bidders.
2. Office of Executive Rural Municipality on behalf of Sarawal Rural Municipality, Nawalparasi invites sealed bids from eligible bidders for the construction of Rural Municipality Building under National Competitive Bidding Single Stage One Envelope Bidding Process.

Bidders submitting their bid electronically should deposit the cost of bidding document NRs. 3000.00 in the Office's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre- Bid Meeting shall be held at Office of Executive Rural Municipality, Sarawal Rural Municipality Sarawal, Nawalparasi at 14 hrs on 21st Feb 2019 (2075/11/9).
6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by minimum bid security, amount listed below which shall be valid for 30 days beyond bid validity period. The bid security issued by "A" class commercial banks shall only be accepted.
7. Bidders may submit their bid electronically only to the Office of Executive Rural Municipality, Sarawal Rural Municipality, Sarawal, Nawalparasi through E-procurement section of PPMO's web site <http://www.bolpatra.gov.np/egp> as specified in the Instruction for Bidders on or before 12:00 hrs 3rd March 2019 (2075/11/19). Documents received after this deadline will not be accepted.
8. Bids will be opened in the presence of Bidders representatives who choose to attend at 14:00 hrs on 3rd March 2019 (2075/11/19) at the Office of Executive Rural Municipality, Sarawal Rural Municipality, Sarawal, Nawalparasi.
9. If the last date of purchasing, submission, opening and pre-bid meeting falls on a government holiday then the next working day shall be considered as the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original submission deadline.
